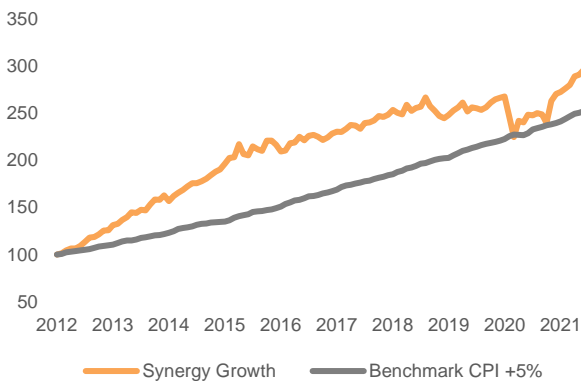

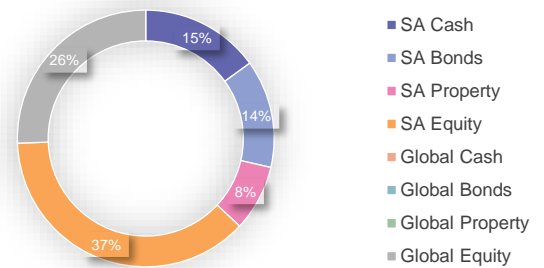

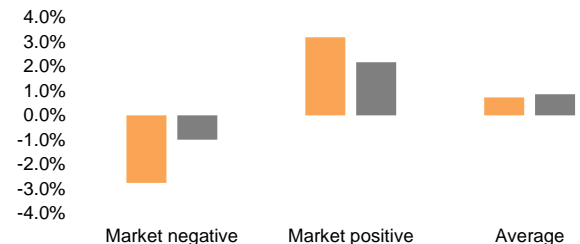
LONG-TERM GROWTH*



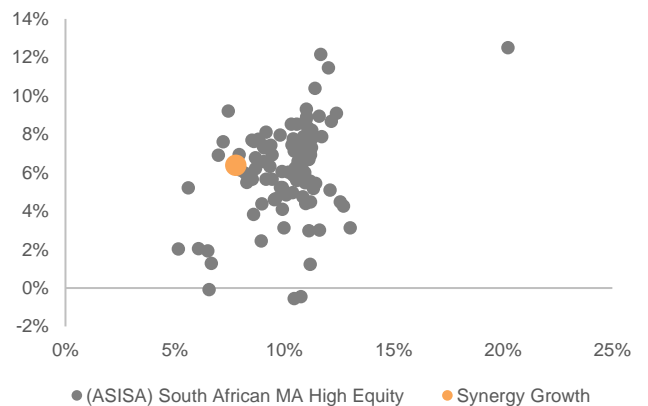
ASSET ALLOCATION
